## TRAVEL DOCUMENTS

A U.S. Citizen must be in possession of a valid passport with not less than six months validity remaining. Non-U.S. Citizens should consult the appropriate consulates or call your travel agent for assistance.

## **DEPOSITS AND PAYMENT**

A deposit of \$1000 per person and a signed reservation form is required to confirm your booking. There is not a deadline for the deposit, however, space is limited and subject to availability at the time your booking is received. Final payment is due no later than May 1, 2019. If reservations are made after final payment date, the entire amount is to be submitted at the time of confirmation. Change and cancellation policies outlined below will apply after services are confirmed.

The \$50 pre-registration deposit will be applied to your booking.

## CHANGES & CANCELLATION ON LAND PACKAGE

Cancellations must be submitted to Borton Overseas in writing. Deposits are refundable for cancellations made in writing **prior to** March 1, 2019. From March 1 – April 30, the deposit is non-refundable; May 1- June 13, a penalty of 50% of the tour cost per person applies; June 14 – departure date, no refund. Refunds can not be made for any tour accommodation, service or feature that you do not utilize or that you voluntarily change; if you cancel while tour is in progress, there will be no refund for unused portions. You will be responsible for any charges involved based on voluntary deviations in the itinerary. **Airline tickets have their own cancellation and change penalties.**

# TRAVEL INSURANCE
