TRAVEL DOCUMENTS

U.S. Citizens must be in possession of a valid passport with not less than three months validity remaining after your planned departure date from Europe. Non-U.S. Citizens should consult their appropriate consulate.

PAYMENT INFORMATION

A per person deposit is required with a completed reservation form. The deposit amount depends on the pre or post tour(s) chosen. Final payment is due no later than June 5, 2020.

CANCELLATION POLICY

Cancellations must be submitted to Borton Overseas in writing. Cancellations received before April 1, 2020 are subject to a penalty of 10% per person; April 2 – June 5, the cancel penalty is 25% per person; June 6 – July 16, a 50% per person penalty will be assessed; July 17 - departure, cancellation penalty is 100%. No refund can be made for any tour, accommodation, service, or feature that passengers do not utilize or voluntarily change; if client cancels while tour is in progress, there will be no refund for unused portions. If any air arrangements are booked, the air ticket carries separate cancellation penalties. After an air ticket is issued, it is generally non-refundable.
